Registration Terms and Conditions

Golden Planners Inc. (GPI) is working with the From Research to Reality Planning Committee and The Psychedelics R2R not-for-profit corporation (hereafter referenced as R2R2022PC) as their professional conference organizer and will be providing registration processing services. All R2R2022 participants must register by providing contact information and paying the applicable fee.

Full conference registration entitles participants to the following:

- Access to all plenaries and sessions (with the exception of the pre-Conference Workshop, which are an additional charge)
- All participant materials
- Public Event
- Conference meals and breaks

Virtual conference registration entitles participants to remotely view the conference program via the Whova conference app. From Research to Reality is building a strong in person experience. The virtual viewing is part of the efforts to ensure equitable access.

The conference fee does not include accommodations, non-program related meals, travel or any other expenses that may be incurred by delegates.

## **Students**

To qualify for the student rate, students must provide proof of full-time registration as an undergraduate, masters or doctoral student at a post-secondary institution. ## **Pre-Conference Workshops**

Pre-Conference Workshops may be subject to minimum and maximum attendance. In the event that the minimum attendance for a pre-conference workshop is not met by April 27, 2022, it may be cancelled by the R2R2022PC and any fees returned to registrants.

## **Payment Terms**

To qualify for the Early Bird fee, registration and payment must be received by GPI by April 1, 2022, 5:00 pm (ET).

The Regular Registration fee will apply to all payments received after April 1, 2022, 5:00 pm (ET).

## **Registration Payment**

All Registration Fees may be paid by Credit Card (VISA, MasterCard or American Express), by Cheque (payable to "Golden Planners Inc.") or by wire transfer or electronic funds transfer (for wire transfer or EFT contact Derrick LeBlanc at [admin@goldenplanners.ca](mailto:admin@goldenplanners.ca)). Registrations will not be processed or confirmed until payment in full is received. Post-dated cheques will not be accepted. Any bank charges incurred must be paid by the sender and not the Conference.

Failure to complete payment may result in access to R2R2022 being denied.

## **Cancellations**

Cancellations for all categories are permitted until April 27, 2022, 5:00 pm (ET). Cancellations received by the applicable deadline will receive a full refund less a 25% administrative fee. Cancellations must be submitted in writing to Golden Planners by email ([R2R2022@goldenplanners.ca](mailto:R2R2022@goldenplanners.ca)). No refunds will be made for cancellations received after the applicable deadline stated above or for no-shows. Substitutions from the same organization are permitted until May 17, 2022, 5:00 pm (ET) and must be submitted in writing as above. Substitution requests require full contact information for the new attendee along with the name of the attendee they are replacing.

## **Alterations to the Conference Program**

The R2R2022PC reserves the right to make alterations without notice to the content, speakers, timing, venue or date of the conference compared to the advertised program.

## **Public Health Considerations**

Given that the COVID-19 pandemic may be ongoing during R2R2022, changes may be required to address public health challenges. As a result, all plans, commitments and agreements with respect to the event, including all of those described or referenced in this document, may be modified in the R2R2022PC's sole discretion. While the R2R2022PC will endeavour to provide as much notice as possible of changes, the evolving nature of the pandemic may limit our ability to do so. In particular, the R2R2022PC reserves the right to limit capacities to the conference and make any other required adjustments.

All attendees to R2R2022 must follow public health measures in place at that time (including but not limited to masking, handwashing, physical distancing, etc.) In addition, if required by the Province of Ontario, attendees must show proof of vaccination (as provided by their jurisdiction of residence) in order to gain access to the event. Failure to provide such certification is not grounds for refund of any fees paid.

R2R2022 will consider exceptions to its mandatory vaccination policy on a case-by-case basis. Generally, accommodations will be considered only for potential attendees who face extraordinary health challenges and for whom all of the available COVID-19 vaccinations are contraindicated. Unequivocal medical information from the individual's treating physician will be required to support an accommodation request. The R2P2022PC will give due consideration to all reasons cited for an exemption to this policy in accordance with human rights legislation.

The R2R2022PC may be limited in its ability to accommodate those who are not vaccinated by the venue owners, government regulations and/or public health. Furthermore, if the R2R2022PC determines that an accommodation is warranted, certain conditions may be imposed on the unvaccinated attendee by which other attendees are not bound. Such conditions may be necessary to minimize the risk of COVID-19 transmission created by the accommodation measure. Some conditions may be imposed by governmental authorities, like Public Health.

An unvaccinated individual considering attending the event should inquire about the accommodation process prior to confirming attendance. Requests should be made in writing directly to Gloria Mufuta at R2R2022@goldenplanners.ca. The request must state the specific reason the individual seeks an accommodation, and any medical proof must be attached.

The Conference Secretariat will send via e-mail a confirmation of Conference Registration and acknowledgement of payment once full payment has been received and processed. Internet registrations with credit card payments are processed and confirmed immediately by e-mail.

In the event a registrant does not complete the Collection, Use and Disclosure of Information Section, the submission of a conference registration form constitutes the consent of a registrant to the use of his or her contact information for these purposes.

In accordance with Canada's anti-spam laws, the R2R2022PC will require expressed consent to contact you for commercial purposes outside of your participation at R2R2022 conference. Acceptance of these terms and conditions are mandatory for R2R2022 registration, and thus do not indicate your expressed consent for future communications. Except as previously noted, your information will not be provided to any third party.

GPI will retain personal information provided to them only for so long as it is required for the purposes stated above. Information about former registrants is not actively maintained.
